- 2) Provide current Schedules I and J (income and expenditures);
- 3) Provide two recent pay stubs for each person. For self-employed persons, provide a year-to-date profit and loss statement (a recommended form called a "Cash Flow Management Report" is available on the Trustee's website);
- 4) Provide verification of any other source of income, including Social Security income, unemployment benefits, disability benefits, retirement, child support, spousal maintenance; and
- 5) Provide your most recent federal income tax return.
